Title : Preparation for implementation of SEEMP Part III development and verification

In accordance with the amendments of MARPOL(International Convention for the Prevention of Marine Pollution from Ships) annex VI that were adapted at 76th session of MEPC(Marine Environment Protection Committee), Carbon Intensity Indicators (CII) regulation of ships(subject to MARPOL Annex VI reg 26.3) of 5,000 gross tonnage and above engaged on international voyages will be come into from Jan 01st 2023. The ships subject to the CII rating should develop Ship Energy Efficiency Management Plan (SEEMP Part III) and it should be approved by Administration or an Recognized Organization(RO), and implement the implementation plan specified in the plan.

* Bulk carrier, Gas carrier, Tanker, Containership, General cargo ship, Refrigerated cargo carrier, Combination carrier, Ro-ro cargo ship (vehicle carrier), Ro-ro cargo ship, Ro-ro passenger ship, LNG carrier and Cruise passenger ship

Korean Register(KR) will be authorized by various flags including Republic of Korea and plan to provide the verification service.

This technical information was issued to provide the information based on the revised guidelines for SEEMP development adopted in the 78th session of MEPC, SEEMP Part III sample and information of Korean Register's verification service on SEEMP Part III.

1. SEEMP Part III Summary

- 1) The ships subject to the CII rating to develop a SEEMP Part III, which includes "CII calculation methodology", "Plan for data collection and data quality", "Required CII for next 3 years", "3-year implementation plan", "Process for self-evaluation and improvement", "Review and update of SEEMP Part III" and "Plan of corrective actions(If applicable)". It should be approved by Administration or ROs by December 31st, 2022 and issued Confirmation of Compliance (CoC) should be kept onboard as well.

- 2) From year 2024, each vessel will be given a CII rating (A,B,C,D or E) based on the reported IMO DCS data for year 2023. If a ship's CII rating is an one E rating or D rating for three consecutive years, the revised SEEMP Part III including the plan of corrective actions to achieve the required CII should be re-developed and approved by Administration or RO.
