		China HQ	<p>1. 정부 정책 : 통제속에서 위드코로나로의 정책변경 추진중*, 외국인 입국제한 지속, 대부분의 포트에서 외국인은 승선 불가.  * (참고) 12월7일에 발표된 신방역 10조 정책 요약:  - 무증상, 경증 감염자는 자가격리 가능  - 식당/유흥업소 진입시 48시간 내 핵산검사 음성증명 폐지  - 핵산검사 최적화(고위험군 직종, 고위험지역 사람만 핵산검사. 요양원, 의료기관, 학교 등을 제외하고 음성증명서 요구않음. 지역간 이동자도 핵산검사 증명 요구않음.)</p> <p>2. 코로나 대응 현황  가. 정부 주도의 대규모 대국민 백신 접종 캠페인 진행 중  나. 백신 미접종자 승선 및 항구 출입 시 제한 또는 코로나 검사 결과 등 각종 안전 증빙 요구하고 있으며 외국인의 경우 절차가 더 까다로움  다. COSCO 등 중국국영조선소를 중심으로 백신 미 접종자에 대한 출입 제한 조치중  라. 해외에서 상하이 지역으로 들어올 경우 "지정격리 5일 + 자가(불가할 경우 지정) 격리 3일" . 지역에 따라 격리기간 지정. 정책 수시 변동하므로 사전확인 필수.  마. 일상생활에는 큰 지장이 없으나 Port는 대부분 진입 불가, 조선소는 방역 조건을 갖춘 case by case로 접근 가능. 단, 조선소 작업 후 7일 격리 필요하며 진입을 위한 방역조건 유지  바. 현재 중국내 다수 지역의 산발적인 감염세 발생(22.12.13. 하루 기준 중국 전체 2,259명 신규 발생, 무증상 감염자 제외*)  * PCR의무 완화로 PCR 검사 수요가 감소함에 따라 무증상감염자 집계 의미가 퇴색됨. 이에 중국정부에서는 이번 주 부터 무증상 감염자를 집계하지 않음.(지난 주는 무증상 감염자 포함기준 2.1만여명)  사. 22.12.13. 현재 중국내 코로나 위험지역은 총 8,176개 지역(고위험- 6,854개 지역/ 저위험- 1,322개 지역)</p> <p>1. Government policy : Policy change to With Corona under control,entry of Foreigners are not allowed and should not embark at the almost port  *(Reference) Summary of the New Quarantine Article 10 policy announced on December 7:  - Asymptomatic and mildly infected people can be self-quarantined.  - When entering a restaurant/entertainment establishment, a negative nucleic acid test result within 48 hours is no more needed.  - Optimization of nucleic acid testing (nucleic acid test only for high-risk occupations, people in high-risk areas, negative certificate is not required except for nursing homes, medical institutions, schools, etc. Person traveling between regions are also not required to prove a nucleric acid test.)</p> <p>2. Corona response status  a. A large-scale public vaccination campaign led by the government is underway  b. Various safety proofs are required, such as restrictions on boarding and entry to ports for unvaccinated persons or corona test results, and the procedure is more complicated for foreigners  c. Restricting access to non-vaccinated people, mainly at Chinese state-run shipyards such as COSCO  d. Designated quarantine of 5 days + self (designated) quarantine of 3 days" is maintained when entering the Shanghai area from abroad.  Total 10 days quarantine. A total quarantine period is designated depending on the region. As the policy changes frequently, prior confirmation is required  e. There is no major disruption in daily life, but most ports are not accessible, Shipyards can be accessed case by case with quarantine conditions. However, 7 days quarantine is required after work at the shipyard. Quarantine conditions for entry are becoming increasingly strict  f. Currently, sporadic infections occur in main parts of China(China- 2,259 cases newly confirmed on Dec.13th 2022. daily based. excluding asymptomatic infected people.*)  * As the demand for PCR tests decreases due to the relaxation of PCR obligations, the Chinese government has not counted asymptomatic infected people since this week. (Last week, approx.21,000 people were counted, including asymptomatic infected people.)  g. As of Dec.13th, 2022, There are a total of 8,176 areas at risk of COVID-19 in China (High risk: 6,854 areas, Low: 1,322 areas)</p>

Covid-19 was recently spread rapidly, so access to Beihai shipyard at Qingdao is very strictly controlled and the other shipyard at Shidao area, all survey is no problem.</p> <p>a. In case of repair shipyard, For foreigners are not allowed at the repair shipyard, supervisors are attending after embarking in the Korea</p> <p>b. In the case of PORT in each region, it is basically impossible for foreigners to board, and whether Chinese inspectors can board is confirmed through AGENT designated as CASE BY CASE.</p> <ul style="list-style-type: none"><li>- Qingdao Port : Not allowed to entering</li><li>- Nanshan Port : Not allowed to entering</li><li>- Rizhao Port : Not allowed to entering</li><li>- Donging Port : Not allowed to entering</li><li>- Dongjiakou Port : Not allowed to entering</li><li>- Yantai Port : Possible to entering</li></ul>

Since the delta virus has been spreaded, almost all ports in Jiangsu province have increased the number of ports where Korean and local surveyors can not be allowed to board. (There are frequent changes about port access procedure.)</p> <p>b. Persons who has entered from overseas should be quarantined 10 days in designated place (7 days) and home (3 days).</p> <p>c. Vaccination before boarding (2 times) + nucleic acid test required at most ports within the jurisdiction (some ports require full body protective clothing)</p> <p>d. Vaccination completed for all Nanjing branch (resident staff + local inspector)</p> <p>e. Nanjing Airport had been re-opened and International line from Nanjing-Incheon is available on or after May 2022.</p> <p>f. There has quarantine only the people who enter Nanjing from dangerous area(14+7) and the other people need PCR test report. PCR test to Nanjing citizen is now still ongoing.</p> <p>g. When people from some of Jiangsu area(Zhenjiang, Yancheng and Lianyungang), Anhui and low dangerous areas intend to enter Nanjing, quarantine is not required if they have effective PCR test report on or after 11 May 2022.</p> <p>h. When surveyor enter Henan Province, PCR test report and 3 days quarantine required.</p>

When purchasing a Ferry ticket, instead of checking the existing GREEN CODE, check the movement history of the past 2 weeks (Wechat) (2021.01/20~)</div><div>d. - Risk Area : Japan, India, Philippines, Russia, Indonesia 5 countries can dock at shipyards in the Zhoushan area 28 days after departure</div><div><div>(If have last port(China) PCR test report(all negative), reduce to 28 intervla days)</div><div>(If no PCR report of any Chinese port, but all crew area Foreign Nationality(no chinese) and vessel commit to departure in case PCR tested abnormal at shipyard, interval days need 21 days)</div><div>- Low Risk : a vessel that has not visited risk area, it is possible to enter a shipyard in Zhoushan area after 14 days of the last port (PCR teas after arrival)</div><div>- First PCR test after birthing and 2nd PCR test &amp; ship's sampling test, If everything is fine, normal shipyard's job from 3rd days after birthing.</div></div><div>e. Fujian Fuzhou Huadong shipyard</div><div>arrive at Huadong shipyard 1 day before &amp; use personnel car only (no train &amp; bus)</div></div>
