Proof of a complete vaccination schedule becomes sufficient to arrive in France, regardless of the country of origin, as was the case before the distribution of the Omicron variant.</p> <p>For unvaccinated travellers, the obligation to present a negative test to travel to France remains, but the measures on arrival (test, isolation) are lifted when they come from countries on the "green" list, characterized by a moderate circulation of the virus.</p> <p>When unvaccinated travelers come from a country on the "orange" list, they must continue to present a compelling reasoning justifying the need for them to come to mainland France and may still be subject to a random test on arrival.
