Dear Sir/ Madam,

Green Incentive Scheme for Hong Kong registered ships

With a view to encourage Hong Kong registered ships that have attained high Carbon Intensity Indicator (CII) ratings under the international standards on decarbonization formulated by the International Maritime Organization (IMO), Marine Department (MD) launches the Green Incentive Scheme (the Scheme) on 28 June 2024.

2. Under the Scheme, all Hong Kong registered ships of 5,000 gross tonnage and above in possession of a valid “Statement of Compliance – Fuel Oil Consumption Reporting and Operational Carbon Intensity Rating” (SoC) showing that the ship has attained CII rating A or B for the respective year between 2024 and 2026 are eligible to receive HK\$20,000 on each corresponding year as specified in the SoC. If a ship attains CII rating A or B throughout 3 years from 2024 to 2026, the ship may then receive a maximum incentive of HK\$60,000. The application period opens from 28 June 2024 to 31 December 2026.

3. Any ship eligible for the Scheme should submit a completed application form together with copies of supporting documents to the MD for approval. The application form together with the Guidance Notes and payment arrangements are enclosed for reference. The application form is also available to download at <https://www.mardep.gov.hk/en/forms/index.html> .

General

1. The Green Incentive Scheme aims to encourage Hong Kong-registered ships that meet the international carbon reduction standards. Hong Kong-registered ships hold a valid Statement of Compliance and attain Carbon Intensity Indicator (CII) rating A or B are eligible to apply.
2. Under the Scheme, each eligible ship which has submitted an application to and been granted approval from MD will receive HK\$20,000 for each successful application. The incentive is to be applied between 28-06-2024 and 31-12-2026 with a valid Statement of Compliance attached.
3. The ship has not applied this Green Incentive for the corresponding year specified in Statement of Compliance
4. The eligible Hong Kong-registered ship must remain her registration with the Hong Kong Shipping Registry (HKSR) on the date the incentive is granted.
5. The applicant can be a ship owner, demise charterer (if applicable), representative person, ship management company, ship agent or others as specified in Part A. No proof of authorization to the applicant is required.
6. The incentive will be paid in the form of a crossed cheque by post. For other payment methods, please contact this office.
7. Regarding the approval of incentive, this office reserves the right of final decision.
8. Completed application form together with copies of all supporting documents may be submitted to the Ship Registration Services Section either by post (Marine Department, Room 302, 3/F, Harbour Building, 38 Pier Road, Central, Hong Kong) or e-mail (greenincentive@mardep.gov.hk). For any enquiries related to this application, please email to the above email address.
9. After receiving the application, MD will conduct document checks. Depending on the actual situation, the incentive for approved application will normally be delivered within three months.

1. 綠色優惠計劃旨在鼓勵香港註冊船舶達到國際減碳標準。持有有效的燃油消耗報告和營運碳強度評級並達到碳強度指標 (CII) A 級或 B 級的香港註冊船舶將合資格申請。
2. 計劃下，每艘申請並成功獲批的合資格船舶將獲得港幣20,000元。此優惠措施的申請可於2024年6月28日至2026年12月31日期間提交，並需附有有效的符合聲明。
3. 船舶沒有就符合聲明中的對應年份申請此綠色優惠。
4. 合資格的香港註冊船舶必須在獲發放綠色優惠當日仍然註冊在香港船舶註冊處。
