		China HQ	<p>1. 정부 정책 : 위드코로나로 정책변경중*.  * (참고) 1월 8일자로 시행된 코로나 관련 국가정책 변경사항:</p> <ul style="list-style-type: none"> <li>o '중화인민공화국 감염병 예방법'에 규정된 A급 감염병 예방 및 통제조치 해제</li> <li>o 핵산검사: 일부 예외(응급환자, 증상있는 의료진, 취약계층 집중장소의 직원 등)를 제외하고 핵산검사는 기본적으로 원하는 사람만 시행</li> <li>o 무증상 감염자, 경증 환자는 자택에서 자가돌봄. 중증 환자 등은 지정병원 치료</li> <li>o 출입국 관련, 국경위생검역법에 따라 입국자, 화물 등에 대한 검역감염병 관리조치는 더이상 실시하지 않음</li> <li>o 중국 입국 예정자에게 요구되는 48시간 전 핵산검사 음성 증명은 그대로 유지하나, 중국 입국 후 검체검사 및 코호트 격리는 취소</li> <li>o 수로, 육로 여객운송의 출입국 점진적 재개</li> </ul> <p>2. 코로나 대응 현황</p> <p>가. 정부 주도의 대규모 대국민 백신 접종 캠페인 진행 중.</p> <p>나. 백신 미접종자 승선 및 항구 출입 시 제한 또는 코로나 검사 결과 등 각종 안전 증빙 요구하고 있으며 외국인의 경우 절차가 더 까다로움</p> <p>다. 일상생활에는 큰 지장이 없으나 <u>Port, 조선소는 방역 조건을 갖춘 case by case로 접근 가능.</u></p> <p>라. 현재 중국내 다수 지역의 산발적인 감염세 발생. PCR검사 의무 완화에 따라 감염자 수 산정이 정확하지 않으므로, 정부는 '22년 12월 4째주부터 감염자 수를 발표하지 않음</p> <p>1. Government policy : Policy change undergoing from strict government control to "With Corona".  * (Note) Changes to corona-related national policies effective on January 8th:</p> <ul style="list-style-type: none"> <li>o Lifting the Class A infectious disease prevention and control measures stipulated in the "Infectious Disease Prevention Law of the People's Republic of China"</li> <li>o Nucleic acid test: With some exceptions (emergency patients, symptomatic medical staff, staff in vulnerable concentration places, etc.), nucleic acid testing is basically performed only for those who want it.</li> <li>o Asymptomatic infected and mildly ill patients are self-cared for at home. Seriously ill patients are treated at designated hospitals.</li> <li>o Quarantine infectious disease control measures are no longer implemented for arrivals, cargo, etc. in accordance with the Border Health and Quarantine Act.</li> <li>o The 48-hour negative nucleic acid test required for prospective arrivals to China will remain in place, but sample testing and cohort quarantine will no longer needed when entering China.</li> <li>o Gradual resumption of waterways, land passenger transport entry and exit.</li> </ul> <p>2. Corona Response Status</p> <p>a. A large-scale public vaccination campaign led by the government is underway</p> <p>b. Various safety proofs are required, such as restrictions on boarding and entry to ports for unvaccinated persons or corona test results, and the procedure is more complicated for foreigners</p> <p>c. There is no major disruption in daily life, but <u>ports and Shipyards can be accessed case by case with quarantine conditions.</u></p> <p>d. Currently, sporadic infections occur in main parts of China. The government has not announced the number of infected people since the fourth week of December 2022.</p>

Covid-19 was recently spread rapidly, so access to Beihai shipyard at Qingdao is very strictly controlled and the other shipyard at Shidao area, all survey is no problem.</p> <p>a. In case of repair shipyard, For foreigners are not allowed at the repair shipyard, supervisors are attending after embarking in the Korea</p> <p>b. In the case of PORT in each region, it is basically impossible for foreigners to board, and whether Chinese inspectors can board is confirmed through AGENT designated as CASE BY CASE.</p> <ul style="list-style-type: none"><li>- Qingdao Port : Not allowed to entering</li><li>- Nanshan Port : Not allowed to entering</li><li>- Rizhao Port : Not allowed to entering</li><li>- Donging Port : Not allowed to entering</li><li>- Dongjiakou Port : Not allowed to entering</li><li>- Yantai Port : Possible to entering</li></ul>
		Nanjing	<p>1. 델타바이러스 확산이후 Jiangsu성 관내 거의 모든 항만에 한국인,현지검사원 승선불가 항구 증가(항만 출입 절차 수시 변경)</p> <p>2. 외국에서 난징으로 입국 시 5+3일 격리시행(2022.11)</p> <p>3. 연운항을 비롯한 관내 대부분의 항만에서 승선전 백신접종(2회)+핵산검사 요구(전신방호복 요구하는 항만도 있음)</p> <p>4. 난징지부 전원(주재원+현지검사원)백신접종 완료</p> <p>5. 2022.05월부터 난징-인천 운항재개</p> <p>6. 중국정부의 방역정책 변경(위드코로나)으로 PCR Test미 실시, 건강코드 제시 의무 면제, 난징 및 강소성 지역 확진자 증가</p> <p>a. Since the delta virus has been spreaded, almost all ports in Jiangsu province have increased the number of ports where Korean and local surveyors can not be allowed to board. (There are frequent changes about port access procedure.)</p> <p>b. Persons who has entered from overseas should be quarantined 10 days in designated place (7 days) and home (3 days).</p> <p>c. Vaccination before boarding (2 times) + nucleic acid test required at most ports within the jurisdiction (some ports require full body protective clothing)</p> <p>d. Vaccination completed for all Nanjing branch (resident staff + local inspector)</p> <p>e. Nanjing Airport had been re-opened and International line from Nanjing-Incheon is available on or after May 2022.</p> <p>f. There has quarantine only the people who enter Nanjing from dangerous area(14+7) and the other people need PCR test report. PCR test to Nanjing citizen is now still ongoing.</p> <p>g. When people from some of Jiangsu area(Zhenjiang, Yancheng and Lianyungang), Anhui and low dangerous areas intend to enter Nanjing, quarantine is not required if they have effective PCR test report on or after 11 May 2022.</p> <p>h. When surveyor enters Henan Province, PCR test report and 3 days quarantine required.</p>
